

Terms and Conditions

1. Information about the prize and how to enter forms part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Terms and Conditions of Entry by each entrant.
2. Entry is open to all legal residents of South Africa, who are South African citizens aged 18 years or older at the time of entering the competition ("Eligible Entrant"), who enter the promotion in the required manner. The names booked must correspond with the names on the ID and passport.
3. Employees of Lanseria International Airport and Flysafair and their immediate families are not permitted to enter.
4. Entry into the competition opens 1 December 2024 and ends **4 January 2025** (the Promotional Period").
5. Only 1 entry per person.
6. There will be 4 winners announced every week
